Course Content	This course is an introduction to the phenomenon of political violence which became more significant in the field of security studies. The students will be introduced with the history, reasons, types and the role of terrorism in international relations and informed about the interrelationship between terrorism and media, freedoms, globalization, technological development and diversification. The first part of the course will examine definitions and concepts. Then the classification of terrorism will be focused. Next part will deal with modern terrorism, motivations of terrorism, organizational structures, strategies, and cases from world politics. In the final part, the politics and strategies to struggle with terror and political violence will be covered. At the end of the term the students are expected to have the basic knowledge of historical background, future and the ways of struggle with terrorism and political violence. Besides, the students are expected to acquire an inter-disciplinary and analytical outlook.
The Aim of the Course	Students will learn terrorism and its history, description, causes, types, ecosystem of terrorism and its national and internationa role in undergraduate level. They will learn the relationships between terrorism and media, law, freedoms, ideolojy, globalization and technological improvements. In the first part of the class, the concepts and descriptions of violence, terror and terrorism will be discussed. Later, the couse will focus on the classification of terrorism. Modern terrorism, motivations of terrorists, organizational structure, terrorist attitudes, strategies, and examples in the world and in Turkey. In the last part, strategies and politics of countering terrorism and terrorism will be discussed. This course helps students gain analytical perspective with an interdisciplinary approach.
Course Outcomes	Students will learn political extremism, the characteristics, causes, history, concepts of terrorism and its negative influence on security.
