INFORMATION ON THE INTERNATIONAL ENTREPRENEURSHIP BACHELOR DEGREE PROGRAM

General Information	The Department of International Entrepreneurship is the first and only department of its field in Turkey. During our training, our students prepare for the language of the region (Russian) in Turkey and in the target region (Russia) in order to be able to learn good local language (Russian) besides English. In addition, our students also take courses in economics, business arts, law and similar regional cultures at the distinguished universities (Moscow State University) of the relevant region (Russia). The department curriculum closes the to the business education curriculum. The main difference from the Business Administration is that it provides to students entrepreneurship knowledge, a second foreign language and experience in living abroad.
Program Purpose	The aim of the International Entrepreneurship Bachelor Program is to develop qualified labor force who dominant in the important commercial regions of the world, have experience in the region and can work in international companies. For this purpose, regions that are important in the foreign trade of Turkey have been identified. Besides having academic qualifications in entrepreneurship, innovation and business at the end of their undergraduate education, our students acquire the language skills of the target region at a good level and they live in the target region (in Moscow) for a year and gain experience in doing business in the region.
Degree Earned	Students who have successfully completed this program are eligible to receive Bachelor of International Entrepreneurship.
Level of Degree Earned	This program is a program that provides education at the undergraduate level (TYYÇ Level 6).
Requirements and Rules of the Degree Earned	To graduate from department; Having received the total number of courses in the program and being successful. Having completed a minimum of 120 credits and 260 ECTS credits from these courses. A weighted grade average of 2.00 and above over 4.00 is sought. It must have successfully completed a joint program in the department program, a one-year preparatory course in a foreign university, and a two-term cultural course in a foreign university.
